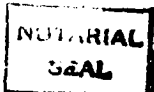

State of Iowa Madison County SS: I, Dennis McDonnell of the County and State afore-
 said first being sworn, on oath depose and say that I was well and personally acquainted
 with John McDonnell and Mary McDonnell his wife, who conveyed the S $\frac{1}{2}$ SW $\frac{1}{4}$ & NW $\frac{1}{4}$ SE $\frac{1}{4}$ Sec-
 17-76-26 and other land to this affiant Dennis McDonnell by warranty deed of date
 September 12th, 1893 which deed was filed for record in the Recorder's office of Madison
 County, Iowa, October 28th A.D. 1893, and recorded in book 33 of deed records of said County,
 at page 256, the said John McDonnell and Mary McDonnell being my father and mother. And
 to my personal knowledge know that the grantee John McDonald in a certain Quit Claim
 Deed of date January 1st, A.D. 1868 and filed for record in the office of the Recorder of
 Madison County, Iowa, on January 11th, 1868, and recorded in record "U" at page 364 of said
 Madison County, Iowa, records, and the grantee John McDonald in a certain warranty deed
 executed by John Harrington and wife Bridget Harrington the 5th day of March A.D. 1870 and
 filed for record in the office of the Recorder of Madison County, Iowa, on same date, and
 recorded in record 3 at page 406 of said Madison County, Iowa, records, are one and the
 same identical person, or in other words the said John McDonnell grantor in the first above
 mentioned deed and John McDonald grantee in the two last above mentioned deeds are one
 and the same identical person.

I further depose and say that A. J. Hoisington grantee in the tax deed above mentioned,
 John McDonnell his grantee, and Dennis McDonnell myself, have had and held actual, open,
 notorious and peaceable possession, occupancy and control of the S $\frac{1}{2}$ SW $\frac{1}{4}$ NE $\frac{1}{4}$ Sec- 17-76-26
 since the execution of the tax deed above described, and that I am now in peaceable
 possession, and occupy said land by living thereon, and have lived thereon for 23 years last
 past, and the Lusian McHoughton or no other person or person has made any claim of any
 kind or character thereto since the execution of said tax deed.
