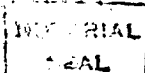

State of Iowa Madison County SS: I, W.F. Craig, of said County and State being first duly sworn, upon my oath depose and say that I am well and personally acquainted with Ernest C. Hamilton, grantee in the warranty deed, recorded in Deed Record 60, page 560, wherein he acquired title to the SE $\frac{1}{4}$ SE $\frac{1}{4}$ Sec. 12 and E $\frac{1}{4}$ NE $\frac{1}{4}$; E $\frac{1}{4}$ SE $\frac{1}{4}$ Sec. 13-75-27; also the S $\frac{1}{4}$ SW. Fr $\frac{1}{4}$ Sec 7, NW Fr $\frac{1}{4}$ Sec. 18, and a part of the SW Fr $\frac{1}{4}$ Sec. 18, described as follows; Commencing at the Northwest corner of said Quarter Section, thence running S. on the W. line thereof to a point 50 rods and 20 links N. of the Southwest corner of said Quarter Section, thence in a northeasterly direction on a straight line to a point on the E. line of said Quarter Section 59 rods and 20 links N. of the Southeast corner thereof, thence N. on the E. line of said Quarter Section to the Northeast corner thereof, thence W. on the N. line thereof to the place of beginning; also a tract in the SW Fr $\frac{1}{4}$ Sec. 18, described as follows:- Commencing 25 rods N. of the Southwest corner of said Quarter Section, thence in a northeasterly course to a point on the E. line of said Quarter Section 34 rods N. of the Southeast Corner thereof, thence N. on the E. line of said Quarter Section 25 rods and 20 links, thence in a Southwesterly course to a point on the W. line of said Quarter Section 25 rods and 20 links N. of the place of beginning, thence S. to the place of beginning; also the W $\frac{1}{4}$ NW $\frac{1}{4}$ SE $\frac{1}{4}$ Sec. 18-75-26, and that said Ernest C. Hamilton is the same and identical person as the E.C. Hamilton, who together with his wife, executed the warranty deed to F.S. Hamilton, dated Feb. 21, 1920 and filed Mar 19, 1920 and conveying the above described land.
