Gordon being first sworn do depose and say that I am _____ years of age and have lived in Madison County, Iowa, _____ years; that I personally knew Josephine S. Berger, who on March 10th, 1860, obtained title 4 acres in a square form out of the south west corner of the south east quarter of Section 36, Township 76 north, Range 28, west 5th P.M., and I know she is the same identical person^{as} Josephine S. B. Ally, who with her husband, conveyed a portion of said land to Charles A. Gaskill on February, 6th, 1865, which deed was recorded in the office of the Recorder of Madison County, Iowa, in record "Q" on page 247; and I know that the said Charles A. Gaskill who obtained said deed above described is the same identical person as C. A. Gaskill, who on September 19th, 1965 executed a deed for a portion of said land to Thomas M. Wilkinson and which deed was recorded in the office of the Recorder of Madison County, Iowa, in record "Q" on page 314 and that at the time of the execution of said deed the said C. A. Gaskill was a single and unmarried man; and I know that the said Thomas M. Wilkinson named in said last described deed and T. M. Wilkinson named as grantor in the Power of Attorney to H. W. Manger and recorded in the office of said Recorder in Record 1 at page 308, and T. M. Wilkinson named as grantor in the Bond for Deed which was recorded in the office of said Recorder in Record 6 at page 576, and the T. M. Wilkinson named as grantor in the quit claim deed

recorded in the office of said Recorder in record 25 at page 173, and the T.M. Wilkinson named as mortgagor in the mortgage recorded in the office of said Recorder in record 4 page 434, and the T.M. Wilkinson named as one of the defendants in the proceedings at the November 1874 term of the C.C. of Madison County, Iowa, and in the judgment in said proceedings as shown at Record 1 at page 279 of said court, and T.M. Wilkinson one of the grantors in the bond for deed recorded in the office of said Recorder on May 19th, 1876 and recorded in record ___ at page ___, are all in truth and in fact one and the same person; and I know that on January 2nd 1878, at the time D.W. Dorchester and A.M. Dorchester executed a warranty deed to J.T. White et al covering a portion of said land and which was recorded in the office of said Recorder in record 16 at page 156 the said D.W. and A.M. Dorchester were husband and wife; and I also know that Abigail A. Shearer to whom W.P. Potter and wife conveyed a portion of said land as shown by record 33 at page 619 of the records of Madison Co., Iowa, and Abigail Shearer to whom H.W. Munger and wife executed a quit claim deed as shown by record 27 at page 379 of said records are in truth and fact one and the same person. That I have no interest in making this affidavit.
