State of Iowa Madison County SS: I, Homer G. Tilton, of said County and State, being first duly sworn on oath depose and say, that I am well and personally acquainted with William Anza Jones, grantee in the Warranty Deed, recorded in Deed Record 62, page 159 of the records of Madison County, Iowa, conveying the S $\frac{1}{2}$  SE $\frac{1}{2}$  Section 36-75-28, and know of my own personal knowledge that said William Anza Jones is the same and identical person as the William A. Jones, who, together with his wife, executed the mortgage for \$9000 upon said land recorded in Mortgage Record 69, page 151 of said records, William Anza Jones being his full, true, and correct name.

I further state that I was well and personally acquainted with Thomas J. Hartley, in Mortgage Record 56, page 134 of the records mortgage in a certain mortgage for \$10,000 given by myself, recorded, 9 $\frac{1}{2}$  Madison County, Iowa, conveying the NW $\frac{1}{4}$  NW $\frac{1}{4}$  Section 13-74-28, and other land, and that said Thomas J. I further state that I am the same identical person as the Homer G. Tilton, who executed a mortgage for \$2000 to S.M.
