State of Iowa County of Madison SS: I, Joseph K. Nickle, first being duly sworn upon oath do depose and say that I am a son of Robert C. Nickle who died on or about the 22nd day of Sept, 1892 seized of the SW $\frac{1}{4}$, NE $\frac{1}{4}$, and the NW $\frac{1}{4}$ of the SE $\frac{1}{4}$ Sec 13-Twp 75- R 26 and other lands and that the above land was bequeathed to my mother Susannah Nickle; that my mother died on or about the 10th day of Dec. 1898 leaving as her children and only heirs-at-law Hezekiah J. Nickle, Aana E. Hodges, Amanda Ibba De Armond, W. T. Nickle, Mary Ida Steel, Oma Rosella De Armond, Joseph K. Nickle, Cassius M. Nickle, and Riley G. Nickle. That in my Father's will my mother's name was spelled Susanna Nickle, and the in list of heirs it was spelled Susannah Nickle, and Susannah Nickle who was appointed executrix of my Father's estate was one and the same person. That Hezekiah J. Nickle, and H. J. Nickle- a grantor in a deed conveying to Della May Shepherd was one and the same person; That Aana E. Hodges mentioned in the list of heirs and Anna E. Hodges, one of the grantors conveying to Della May Shepherd is one and the same person; That Amanda J. Dearmond and Amanda Ibba De Armond grantor, conveying to Della May Shepherd is one and the same person; That Riley G. Nickle, as given in the list of heirs and R. G. Nickle, one of the grantors, conveying to Della May Shepherd is one and the same person. That Cassius M. Nickle, given in the registry of heirs and C. M. Nickle, one of the grantors conveying to Della May Shepherd is one and the same person; That Joseph K. Nickle and J. K. Nickle one of the grantors conveying to Della May Shepherd is one and the same person; That Oma Rosella Dearmond, in the registry of heirs, and Oma R. DeArmond one of the grantors conveying to Della May Shepherd is one and the same person.

That the grantors H. J. Nickle, Mary Ida Steel, Aana E. Hodges, W. T. Nickle, R. G. Nickle, C. M. Nickle, Amanda Ibba DeArmond, and Oma R. DeArmond conveying to Della May Shepherd on Feb. 24, 1899 were all and the only heirs at law of Susannah Nickle. That Della May Shepherd grantee as shown in deed Record 31 page 385 of Madison County, Iowa, and Della May Shepherd who conveyed to A. J. Heinlen as shown by deed record 4 page 448 is one and the same person that I was well and personally acquainted with the said Della May Shepherd.

Also that I was well and personally acquainted with A. J. Heinlen above mentioned as grantee; and that as shown by deed record 43 page 326 in which Andrew J. Heinlen and wife conveyed to John M. Huzum, and I knew that A. J. Heinlen and Andrew J. Heinlen are one and the same person.

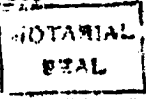
