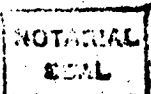

State of Iowa Madison County SS: I, E.E. McCall of said State and County first being duly sworn upon my oath depose and say that I was well and personally acquainted with J.P. Kirk who together with his wife conveyed the NW 1/4 NW 1/4 34-75-27 to Thomas J. Kirk on Rogember 22nd, 1879 and I well and personally know that he is the same and identical person as John B. Kirk to whom Thomas J. Kirk and wife conveyed the NW 1/4 NW 1/4 34-75-27 on December 17th, 1878, and I further depose and say that to my personal knowledge D.B. Kirk who together with his wife conveyed the N 1/2 NW 1/4 34-75-27 to James Early on September 9th, 1889 is the same and identical person as Daniel B. Kirk devisee under the last will and testament of J.B. Kirk and one of the persons to whom he devised the said N 1/2 NW 1/4 34-75-27, and that C.W. Kirk who together with his wife conveyed the undivided 1/5 of N 1/2 NW 1/4 34-75-27 to Thos. J. Kirk on October 15th, 1889 is the same and identical person as Charles W. Kirk one of the devisees named in the will of said J.B. Kirk, deceased, and that T.J. Kirk the grantee in said deed from C.W. Kirk and T.J. Kirk the grantee in a certain deed from Josephes Kirk and wife, dated December 9th, 1889 and conveying 20 acres off of the East end of the N 1/2 NW 1/4 34-75-27 is the same and identical person as Thomas J. Kirk one of the devisees named in said will of J.B. Kirk and that Jacob Wright Kirk who together with his wife conveyed to Josephus Kirk the undivided 1/5 of the N 1/2 NW 1/4 34-75-27 on November 30th, 1889 is the same and identical person as J. Wright Kirk one of the devisees named in said will of J.B. Kirk, and I further depose and say that to my personal knowledge Josephus Kirk and Josephes Kirk are one and the same person, and that Wm. T. Jesse to whom the 20 acres off of the East end of the N 1/2 NW 1/4 34-75-27 was conveyed on July 7th, 1890 is the same and identical person as W.T. Jesse who together with his wife conveyed said land to G.W. Hann on February 21st, 1891 and that George W. Hann who has made an application to the Connecticut Mutual Life Insurance Co. for a loan of \$1000.00 on the N 1/2 NW 1/4 34-75-27 is the same and identical person as G.W. Hann to whom said land is conveyed.
