State of Iowa, Madison County SS: I, Thomas H. Travis being first duly sworn upon oath depose and say that I am now and have been a resident of Madison County, Iowa, for more than 62 years, last past, except about 7 years that I resided in the State of Kansas.

That I am a son of Martin B. Travis who acquired title to the SE $\frac{1}{4}$ NE $\frac{1}{4}$ Sec. 21-74-27, and other land, by deed of conveyance of record in Deed Record "F", page 581 of the records of Madison County, Iowa, and that if his name appears in the record of said deed as Martin B. Trabis the same is only through clerical error or mistake, and should have been written in the record of said deed as Martin B. Travis.

That the estate of my said father Martin B. Travis was probated in the Circuit Court of Madison County, Iowa, as M. B. Travis; that he left surviving him his widow, Lavina C. Travis, and the following persons as his children and sole and only heirs at law, to-wit: Sylvester N. Travis, Mary E. Travis intermarried with James Foresman, Wm. M. Travis, John B. Travis, Lavina C. Travis intermarried with John Schoenenberger, Thomas H. Travis this affiant, Samuel C. Travis and Eva M. Travis; that he left no other child, no issue of any deceased child and no adopted children.

That said Eva M., (or Eva May) Travis intermarried with Albert F. Foster.

That Sylvester N. Travis named in the Registry of Heirs filed in the estate of M. B. (or Martin B.) Travis was the same and identical person as the S. N. Travis who joined in the execution of the Warranty Deed of record in Deed Record 31, page 609 of said records, and the same person as Sylvester N. Travis named in said deed.

That Mary E. Travis Foresman named in said Registry of Heirs was the same and identical person as the Mary E. Travis who joined in the signing of said ^{last} described deed.

That the name of James Foresman included in said Registry of Heirs was an error as James Foresman was the husband of Mary E. Travis, as above stated.

That Wm. M. Travis named in said Registry of Heirs was the same and identical person as the W. M. Travis who joined in the execution of said last described deed, and the same person as Wm. M. Travis mentioned in said deed.

That Lavina C. Schoenenberger named in said Registry of Heirs was the same and identical person as the Lavina Schoenenberger who joined in the execution of said last described deed, and the same person as Lovina C. Schoenenberger named in said deed.

That the name of John Schoenenberger was included in said Registry of Heirs through error as he was the husband of said Lavina C. Schoenenberger.

That Samuel C. Travis named in said Registry of Heirs was the same and identical person as the S. C. Travis grantor in the Warranty Deed of Record 24, page 421, of said records, and the same and identical person as the S. C. Travis grantee in the Warranty Deed of record in Deed Record 26, page 190 of said records and the same and identical person as the Samuel C. Travis, who joined in the execution of said deed recorded in Deed Record 31, page 609.

That Lovina C. Travis mentioned in said deed of record in Deed Record 31, page 609 was the same person as Lavina C. Travis who joined in the execution thereof.

That Eva M. Travis named in said Registry of Heirs was the same and identical person as the Eva M. Foster named as grantee in said deed recorded in Deed Record 24, page 421, and the same and identical person as the Eva M. Foster who joined in the execution of said deed recorded in Deed Record 26, page 190, and the same and identical person as the Eva M. Travis, who joined in the signing of said deed recorded in Deed Record 31, page 609 with A. F. Foster, her husband and with others, she having signed her name to said deed as Eva M. Travis instead of Eva M. Foster. I further state that I now have no interest whatever in the title to the land herein described, but make this affidavit at the request of the present owner thereof for the purpose of establishing of record the facts herein stated.
