Wittnesseth; That the said party of the first part, for the consideration of Fifteen Thousand Eight Hundred Dollars, the receipt whereof is hereby acknowledged, do by these Presents Grant, Bargain, Sell and Convey unto the said party of the second part, his successors and assigns forever, the following described real estate, lying and being situated in the County of Madison and State of Iowa, to-wit:

The East one half of the South East Quarter of Section Thirty Two (32) And the West one half of the South West Quarter of Section Thirty Three (33). All in Township Seventy five (75) North in Parise Twenty nine (29) West of the 5th P.M. . Iowa.

TO HAVE AND TO HOLD the premises above described, with all the appurtenances thereunto belonging, unto the said second party and to his successors and assigns forever. The said party of the first part hereby covenanting that the above described premises are free from any incumbrances and he will Warrant and Defend the Title unto the said party of the mecond part, his muccessors and assigns, against all persons whomever lawfully claiming the same: Provided Always, and these presents are upon this express condition, that if the said T.C. Phillips his heirs, executors, or administrators, shall pay, or cause to be paid, to the said Jespeh Steele Jr.as Erustee aforesaid. his successors.executors, and administrators er assigns the sum of Fifteen Thousand Eight Hundred Pollars on the final settlement of the Estate of Joseph Steele Sr. deceased shown by the Records in the District Court of Madison Co. Iowa, and also when grappee furnishes an abstract to the above described land as per contract, and

with interest thereon from March 1st, 1921, according to the tenor and effect of the one promissory note of the said T.C. Phillips payable to Joseph Steele Jr. as Trastee said bearing date March 1st, 1921 then these presents to be void, otherwise to remain in full force.
