Hayden who is grantee in a certain deed dated October 17th 1900 and recorded in Deed Record 12, page 369, in the office of the County Recorder of Madison County Iowa wherein G.L. Holmes and wife Alda I. Holmes were grantors, is one and the same person as Nathaniel A. Hayden who died testate on or about November 21st, 1910, and whose will was probated in Madison County, Iowa, on December 26th, 1910.

I further depose and say that William T. Hayden named in the Registry of Heirs in the said estate of Nathaniel A. Hayden is the same person as T.W. Hayden who is named as one of the grantors in the deed dated September 27th, 1912 and recorded in Town Lot deed

Miscellaneous Record, No. 20, Madison County, Iowa.

Record 10, page 588, in the office of the County Recorder of Madison County Iowa wherein G.W. Youmans is grantee conveying West Eight (8) feet of Lot Five (5) and all of Lot Six (6) in Block One (1) Hull's Addition to Truro, Iowa, and that Sarah B. Hayden was his wife; also, that Eliza Hayden named in the said Registry of Heirs is the same person as Elijah Hayden who is named as one of the grantors in the said deed and that Martha A.
