State of Iowa Madison County SS: I, E.F. Connoran, of said County and State, being first duly sworn upon oath depose and say that I am now and have been a resident of Madison County, Iowa, for more than 28 years last past; that I was well and personally acquainted with the parties hereinafter named.

That Daniel C. Schmitt, grantee in the warranty deed of record in Town Lot Deed Record 9, page 5 of the records of Madison County, Iowa, conveying the N $\frac{1}{2}$  of Lot 5 in Block 27 of the Original Town Plat of Winterset, Iowa, is the same and identical person as the D.C. Schmidt who conveyed said property to T.C. Gilpin by deed, recorded in Town Lot Deed Record 12, page 271 of said records.

That said T.C. Gilpin grantee in said last mentioned deed, recorded in Town Lot Deed Record 12 page 271 of the records of Madison County, Iowa, was the same and identical person as the Thomas C. Gilpin, who, together with his wife, conveyed said property to Mrs. Martha H. Litton by deed of record in Town Lot Deed Record 15, page 508 of said records.

That Thomas C. Gilpin, mortgagee, in a certain mortgage, recorded in Mortgage Record 44, page 187 of said records, conveying said property was the same identical person as the T.C. Gilpin, who released the said mortgage on the margin of the record thereof.

That Challen Danforth, one of the grantees in the warranty deed recorded in Deed Record "V", page 52 of said records, conveying Lots 5 and 6 in Block 27 in the Original Town Plat of Winterset, Iowa, was the same and identical person as the Challen Danforth, who joined in the execution of the warranty deed, recorded in Deed Record 1, page 187 of said records, conveying all of said last described property, except the East 20 feet of said Lot 6.

That Wm R. Danforth, grantee in said deed, recorded in Deed Record "V", page 52 was the same and identical persons as the W.R. Danforth, who joined in the execution of said deed, recorded in Deed Record 1, page 187, and the same and identical person as the William R. Danforth named at various places in said last mentioned deed.

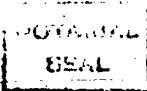
