State of Iowa Madison County SS: I,G.W.Kingery,of said county and state,being first duly sworn,do,upon my oath,depose and say;- That I am a brother of R.G.Kingery,who died testate in Madison County,Iowa, on the 25th day of April,A.D.1899 seized in fee of the South Half ( $\frac{1}{2}$ ) of the Southeast Quarter ( $\frac{1}{4}$ ) of Section Twenty (20) and the North Half ( $\frac{1}{2}$ ) of the Northeast Quarter ( $\frac{1}{4}$ ) of Section Twenty nine (29) all in Township Seventy-four (74) North,of Range Twenty eight (28) West of the 5th P.M.; that I was personally and well acquainted with said R.G.Kingery and with his wife Ann R.Kingery and with the several members of their family; that at the time my said brother R.G.Kingery was married to the said Ann R.Kingery she, the said Ann R.Kingery,had two children by a former marriage named Polly Kingery and Thomas Kingery,their father Thomas Kingery being a second cousin of the said R.G.Kingery and of myself and he having died several years prior to the marriage of said R.G.Kingery with said Ann R.Kingery;that at the time of the death of said Ann R.Kingery she left survivingher as her sole and only heirs at law the said Polly Kingery,then intermarried with one Emerson Gray and subsequently intermarried with a man by the name of Mains, Thomas Kingery (both children by a former marriage) Ira Kingery, Amos Kingery and R.G.Kingery Jr ( the last three named being children of said R.G.Kingery and Ann R.Kingery),that at the time of the death of said Ann R.Kingery both the said Polly Kingery (Gray and later Mains) and Thomas Kingery had attained their majority and had each been married; that the said Ann R.Kingery left surviving her no child or children of any deceased child and no child by adoption but left as her sole and only heirs at law the five children heretofore named herein; that I know all of the facts recited herein of my own personal knowledge and that I have no interest in making this affidavit other than to establish the facts herein stated and have no interest in any way whatever in or to any part of the real estate herein described and I make this affidavit at the request of the present owner of said real estate who is in possession thereof and for the purpose of explaining or curing a defect in the title thereto and this affidavit is to be recorded by such owner in possession for that purpose.
