KNOW ALL MEN BY THESE PRESENTS, that the MIDLAND MORTGAGE COMPANY a Corporation organized and existing under the laws of the State of Iowa, with principal office in the City of Cedar Rapids, County of Linn and State of Iowa, party of the first part, in consideration of the sum of Five Dollars, the receipt whereof is hereby acknowledged, and for other good and valuable consideration, has bargained and sold, and by these presents does grant, bargain, sell, assign, transfer and set over unto John Hancock Mutual Life Insurance Company party of the second part, a certain Indenture of Mortgage made and executed by Paul Clausen and Lucy Clausen, his wife and dated April 21st, A.D. 1922, together with bond therein referred to; which Mortgage was recorded in the office of the Recorder in and for the County of Madison and State of Iowa on the 26th day of April A.D. 1922, in Book 63 of Mortgages, on Page 420

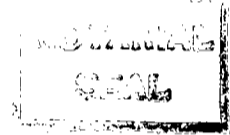
