State of Iowa, Madison County SS: We, Mila Daugherty and Flora Bowers, both being duly sworn, depose and say as follows:- That we are the only children and only heirs at law of Stephen Steel, deceased and Jane Steel, deceased, both late residents of Madison County, Iowa, That the said Jane Steel, our mother, died intestate in Madison County, Iowa, on the 10th day of March A.D. 1904, leaving the said Stephen Steel, our father, as her surviving husband, and that the said Stephen Steel did not re-marry. That the estate of the said Jane Steel was fully settled outside of court and all debts, claims and charges against the same fully paid and settled.
