KNOW ALL MEN BY THESE PRESENTS: That J.A.Polke (single) of Madison County and State of Iowa, in consideration of the sum of Two Thousand and No/100 Dollars, in hand paid by Simon Snyder of Madison County, and State of Iowa do hereby sell and convey unto the said Simon Snyder the following described premises situated in the County of Madison and State of Iowa, to-wit:

All that part of the fractional southwest quarter of the south west quarter of section eighteen in township seventy seven, north, of range twenty seven west of the 5th P.M. Iowa, which lies east of the following described line. Commencing at a point on the south line of said fractional forty acre tract forty six rods and eight feet east of the southwest corner thereof and running thence in a straight line north to a point eighteen and one half rods south of a point on said line forty six rods and fiften feet east of the northwest corner of the said fractional forty acre tract, thence east thirtten rods, thence north parallel with the said north and south line eighteen and one half rods to the north line of the said fractional forty acre tract.

Optional payments of \$500.00 or multiple on any interest paying day, with interest thereon at $5\frac{1}{2}$ % annual according to the tenor and effect of the one promissory note of the said J.A. Polke payable to Simon Snyder bearing even date then these presents to be void, otherwise to remain in full force.

It is hereby agreed that said J.A. Polke shall pay all taxes and assessments levied upon said real estate before the same shall become delinquent, and in case not so paid, the holder of this mortgage may pay such taxes or assessments and be entitled to interest on the same at the rate of eight per cent per annum, and this mortgage shall stand as security for such taxes, assessments and interest so paid.

That so long as this mortgage shall remain unpaid the said J.A. Polke shall keep the buildings thereon insured in some responsible company or companies which shall be satisfactory to the holder of this mortgage for the use and security of said mortgagee in the sum of not less than \$--, and shall deliver the policies and renewal receipt therefor to said mortgagee, and if the said J.A.
