STATE OF IOWA, Madison County, ss. I, W.F.Craig, being first duly sworn do upon oath depose
and say that I am now and have been a resident of Madison County, Iowa, for more than 10
years last past. That I am now and have been since about the Year 1920, well and personally
acquainted with T.A.Tilton, grantee in the Warranty Deed recorded in Deed Record 65, page
426, of the Records in the Recorder's Office of Madison County, Iowa, by which Deed H.A.Tilton
and wife conveyed to the said T.A.Tilton the S $\frac{1}{2}$ E $\frac{1}{2}$ SE $\frac{1}{4}$ and the SW $\frac{1}{4}$ SE $\frac{1}{4}$, except therefrom 5
acres described as follows: Commencing at the Northwest corner of the last described 40 acre
tract, running thence S $\frac{1}{2}$ 20 rods, thence to the Northeast corner of said 40 acre tract, thence
West to the Place of beginning, all in Sec.13; and N $\frac{1}{2}$ NE $\frac{1}{4}$ of Sec.24, all in Township 76,
Range 28, and the fractional SW $\frac{1}{4}$ SW $\frac{1}{4}$ of Sec.18-76-27, except therefrom the E $\frac{1}{4}$ acres, also

I further state that wherever the names T.A.Tilton and Theodore A.Tilton appear in con-
nection with the title to said described real estate, the same in each and every instance
refer to one, the same and identical person, Theodore A.Tilton, that being his full, true, and
correct name. I further state that I am well and personally acquainted with R.W.McKimmy,
named as one of said defendants, and know of my own personal knowledge that said R.W.McKimmy
