And now on this 14th day of January, A.D. 1922, the same being one of the regular Judicial days for the hearing and determination of causes of the January A.D. 1922, Term of said Polk District Court, the above entitled cause comes regularly on for hearing to the Court on the application of the State of Iowa, upon the relation of Ben J. Gibson, Attorney General of the State of Iowa, for an order appointing a permanent receiver of and over the National Live Stock Insurance Company; the plaintiff appears by Ben J. Gibson, Attorney General of the State of Iowa; Guy S. Brewer, temporary receiver of the National Live Stock Insurance Company, appears in person and by Stipp, Perry, Bannister & Starsinger, his attorney; the National Live Stock Insurance Company comes not but makes default; and the Court now examines the records and files in this cause and finds that due and legal notice of the hearing of said application was given to and served upon the Insurance Commissioner of the State of Iowa on January 7, 1922, and upon defendant, National Live Stock Insurance Company, on January 7, 1922, and that returns of service thereon of the notices given as aforesaid were duly filed and made matter of record in this cause on January 14, 1922, and the Court finds that it has jurisdiction of the parties to this cause and of the subject matter, and that the allegations in the application for a permanent receiver are true, and that the best interests of the stockholders and creditors of the National Live Stock Insurance Company require that a permanent receiver be appointed thereof to wind up said corporation, collect and reduce its assets to money, pay off and discharge the liabilities of said company and distribute the residue amongst the stockholders. WHEREFORE, it is by the Court considered ordered and decreed that Guy S. Brewer be and he is hereby appointed permanent receiver of the National Live Stock Insurance Company, and his official bond as such permanent receiver is hereby fixed in the sum of \$50,000.00.

It is further by the Court considered, ordered and decreed that Guy S. Brewer as temporary receiver of the National Live Stock Insurance Company, forthwith file a final report of his doings in the premises, and that he true and correct account render to the court of all of the assets coming into his hands as temporary receiver, of all of the disbursements made by him under order of Court as temporary receiver, and of all of the assets remaining in his hands as temporary receiver, together with a report of all other assets belonging to the National Live Stock Insurance Company in the possession of said temporary receiver of which he has knowledge.
