duly sworn, upon oath depose and say, that I am the same and identical person as the W.C.  
Krabiel named as one of the heirs at law of M.J.K.Bowlsby, Deceased, whose estate was pro-  
bated in the District Court of Madison County, Iowa, and entered in Probate Docket "F", page  
359, and that I have personal knowledge of the facts hereinafter stated. That Bertha Wey-  
hranch named in the Last Will and Testament of B.F.Bowlsby, Deceased, whose estate was pro-  
bated in the District Court of Madison County, Iowa, and entered in Probate Docket "G", page  
435, is the same and identical person as the Bertha Weyhrauch named as one of the defend-  
ants in the action for partition wherein W.H.Bowlsby and myself are plaintiffs and Minnie  
Gregory, et al. are defendants, said action being in the District Court of Madison County,  
Iowa, and entered in Appearance Docket "Y", page 229. That the Frank O.Bowlsby, named in  
the said Last Will and Testament of B.F.Bowlsby, Deceased, is the same and identical person  
as the Frank Bowlsby named in said partition action. That the Clarence Bowlsby named  
in said Last Will and Testament of B.F.Bowlsby, Deceased, is the same and identical person  
as the C.C.Bowlsby named as one of the defendants in said partition action. That the  
Fred Bowlsby named in said Last Will and Testament of B.F.Bowlsby, Deceased, is the same  
and identical person as the Fred A.Bowlsby named as one of the defendants in said partition  
action. That the Emmet Bowlsby named in said Last Will and Testament of B.F.Bowlsby,  
Deceased, is the same and identical person as the Lacey E. Bowlsby named as one of the def-  
endants on said partition action. That the Blanche Weyhranch named in said Last Will  
and Testament of B.F.Bowlsby, Deceased, is the same and identical person as the Blanch Wey-  
hrauch named in the proceedings had in said partition action, and the same and identical

person as the Blanche C. Bowsby named as grantee in the Quit Claim Deed executed by B.F. Bowsby and wife, M.J.K. Bowsby, recorded in Deed Record 39, page 296 of the records of Madison County, Iowa. That Gertrude K. Eymann (or Eymann) named in the said Last Will and Testament of M.J.K. Bowsby, Deceased, died prior to the death of her mother, the said M.J.K. Bowsby.
