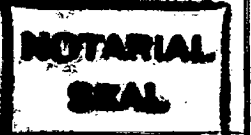
The West Half ($W\frac{1}{2}$) of the Northeast Quarter ($NE\frac{1}{4}$) and the North Half ($N\frac{1}{2}$) of the Northwest Quarter ($NW\frac{1}{4}$) of the Southeast Quarter ($SE\frac{1}{4}$) all in Section Seven (7) all in Township Seventy-seven (77) North, Range Twenty-eight (28) West of the 5th P.M. excepting the two tracts of land described as follows: Commencing at the Northwest corner of the said Fractional Northwest Quarter ($NW\frac{1}{4}$) thence East 610 feet, thence south 660 feet, thence west 610 feet, thence North to the place of beginning; also except the tract of land described as follows: Commencing 610 feet east of the Northwest corner of the said Fractional Northwest Quarter, thence East on the Sectional line to the Northeast corner of the said Northwest Quarter, thence South 810 feet, thence west to a point 610 feet East of the West line of said Northwest Quarter, thence North to the place of beginning, the last described tract being platted as Taylor's Addition to the Town of Earlham, Iowa, also excepting about One (1) acre in the Railroad right-of-way, and Out-lot Seventeen (17) Official plat of the Original Town of Earlham, Iowa.
