State of Iowa, Madison County, ss. I, Jennie McKibben of Earlham, Madison County, Iowa, being
duly sworn, on oath depose and say that I am a daughter of Mary C. Mark of Earlham, Iowa, and
William A. Mark, Sr., who died at Earlham, Madison County, Iowa, on or about December 21st, 1914;
that his estate was probated in the District Court of Madison County, Iowa, the proceedings
of which are recorded in Madison County Probate Records Number 2304, Probate Wocket "C", Page
7.
That at the time of his death he was owner of, and occupied as his homestead, the prem-
ises described as follows: Lots Three (3) and Four (4) in Block Three (3) of Johnson's Addi-
tion to the Town of Earlham, Madison County, Iowa;
That when the aforesaid premises were conveyed to him by E.L. Perrier and wife, Fannie
by a certain warranty deed dated August 9th, 1910, and filed for record in the office of the
Recorder of Madison County, Iowa, on December 16th, 1910, in Town Lot Deed Record 16 at Page
471, his name as grantee in said Warranty Deed appeared as W.A. Mark, but that his true and
correct name was William A. Mark, Sr., and that he was one and identically the same person as
William A. Mark, and William A. Marks, Sr., mentioned in the aforesaid probate proceedings;
That I am a sister of William A. Mark, Jr. named as one of the Heirs at law of my father
the said William A. Mark, Sr., in the Registry of Heirs in the probate proceedings had on his
estate in Madison County, Iowa; that the said William A. Mark, Jr., is one and identically the
same person as W.A. Mark, Jr., mentioned as an Heir at Law in said probate proceedings; and
that the said William A. Mark, Jr., is living at this time and resides near De Soto, Iowa.
That my mother, the said Mary C. Mark, is one and the same identical person as Mary C.
Mark, and Mary C. Mark, mentioned in the aforesaid probate proceedings as the widow of William
A. Mark, Sr., deceased.
That I am a sister of Sidney Mark who was one of the Heirs at Law of my father, the
said William A. Mark, Sr., and whose name appears as Sidney Mark, and also as Sydna Mark, in
the aforesaid probate proceedings; that the said Sidney Mark, and Sydna Mark is one and iden-
tically the same person, and that his true and correct name is Sidney Mark.
