Amendment to Articles of Incorporation of the Peru Savings Bank.

Know All Men By These Presents: That at a regular meeting of the stockholders of PERU SAVINGS BANK of PERU, IOWA Bank a corporation duly organized under the laws of the State of Iowa, held at the office of the Bank in PERU, MADISON County, Iowa, on the 7th day of DECEMBER A. D. 1920 after due and legal notice had been given to the stockholders thereof in conformity with its articles of incorporation, Section 1615, laws of the state, at which the requisite majority of the stock of said corporation was represented, the following amendment was adopted:

Total number shares of stock outstanding 49

Total number shares of stock represented at this meeting 111

Total number shares of stock voted in favor of amendment 111

Amendment: ARTICLE SIX (6) of the BY LAWS of PERU SAVINGS BANK pertaining to the time of its stockholders annual meeting is hereby amended to read as follows: "That on and after January 3rd 1922, the regular annual meeting of the stockholders of this bank shall be held at the banking house on the first Tuesday after the first Monday in January of each year. The date of said meeting as herein given shall supersede, cancel and repeal the original date of said meeting as previously held on the first Tuesday in December of each year."

The President and Cashier of the Bank were duly authorized and directed to sign, acknowledge, record, publish and do all things which are by law required, to execute, complete
