W. Conway and wife, Kate Conway, to the Security Loan and Title Company, of Winterset, Iowa, and recorded in the Office of the Recorder of Madison County, Iowa, in Mortgage Record 66, page 26 on the 6th day of September, A.D. 1917, is fully paid, satisfied, released and discharged.

The said "PRESBYTERIAN BOARD OF MINISTERIAL RELIEF AND SUSTENTATION" being the name, style and title of the Corporation under which said "PRESBYTERIAN BOARD OF RELIEF FOR DISABLED MINISTERS AND THE WIDOWS AND ORPHANS OF DECEASED MINISTERS" and the "MINISTERIAL SUSTENTATION FUND" with all their rights and privileges, etc., were merged and consolidated by Decree of the Court of Common Pleas No. 1, of Philadelphia County, Pennsylvania, as of December Term, 1908, No. 1700, entered October 28th, 1918, and recorded in the Office of the Recorder of Deeds for the said County of Philadelphia, and State of Pennsylvania, in Charter Book No. 59, page 448, on November 7, 1918.

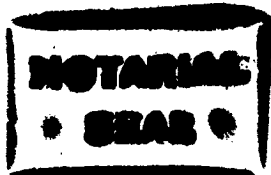
