I further state that the Judgment against Ernest Smith in favor of Dr. Wilton McCarthy entered in Judgment Docket "Z", page 212 in the Office of the Clerk of said Court is not against my brother George E. Smith also named in said Registry of Heirs.

I further state that the Judgment against Earl Smith entered in Judgment Docket 25, page 99 in the Office of the Clerk of said Court is not against my said brother, George E. Smith.
