AFFIDAVIT

STATE OF IOWA, UNION COUNTY, SS: I, Adam Busch, of Madison County, Iowa, being first duly sworn do upon my oath depose and say that I have been a resident of Madison County, Iowa, for more than 52 years last past, and that I was well and personally acquainted with Mary Emma Harrison, grantee in the warranty deed dated Oct. 29, 1910, recorded in Town Lot Deed Record 16, page 501, of the records in the office of the Recorder of Madison County, Iowa, conveying Out Lots 4 and 5 of Lee's Addition to the Town of Macksburg, Madison County, Iowa, and I know of my own personal knowledge that she is the same and identical person as the Mary Emma Harrison Young, who, with her husband, Eugene A. Young, conveyed said property to one J. W. Iler by warranty deed dated Feb. 25, 1913, and recorded in Town Lot Deed Record 14, page 642, of said records, she having intermarried with the said Eugene A. Young prior to the execution of the last above mentioned deed, and the said Eugene A. Young who joined with her in the execution of said last mentioned deed was her husband at the date of the execution of the same.

I further state that the Amanda J. Iler named in the certificate of acknowledgment of the warranty deed dated Feb. 28, 1916, recorded in Town Lot Deed Record 21, page 2, of said records, conveying said property, is the same and identical person as the Amanda Iler who executed the same and who is named therein as the wife of J. W. Iler, the other grantor, said deed conveying said property to Rex M. Wilder.

I further state that I was well and personally acquainted with the I. D. Harrison, grantee in the warranty deed dated Mar. 5, 1910, recorded in Town Lot Deed Record 16, page

373, of said records, and grantor in the warranty deed dated Oct. 29, 1910, and recorded in Town Lot Deed Record 16, page 501, conveying said property, and know that the said I. D. Harrison is not the David Harrison against whom delinquent personal taxes appear in the office of the Treasurer of Madison County, Iowa, for the years 1891, 1892, 1893, 1894, 1898 and 1900, assessed in Winterset in the respective amounts of \$.50, \$.90, \$.50, \$.50, \$1.02, and \$1.00, as the said I. D. Harrison never lived in Winterset or had property there subject to taxation for said years.

I further state that I am in no way interested in the title to the property above described, but make this affidavit at the request of the present owner thereof for the purpose of establishing of record the facts above stated, of which I have personal knowledge.
