AGREEMENT FOR EXTENSION

WHEREAS, Henry Thomsen and Anna Thomsen, husband and wife, did on the 9th day of January 1914 execute and deliver to Bankers Life Company a certain mortgage which was recorded in book 57 on page 25 of the records of Madison County, Iowa, to secure the payment of a certain note for \$25,000.00 and interest; now Frederick W. Martens and Anna Martens, husband and wife, hereby assumes and agrees to pay the same with interest at the office of the Bankers Life Company, Des Moines, Iowa.

It is further agreed that all the terms, conditions and stipulations contained in said note and mortgage shall continue in full force and effect excepting only as modified by this agreement.

One hundred dollars or multiple thereof may be paid at any interest date on and after March 1, 1929
