WHEREAS, there remains unpaid on a certain note executed and delivered by Elkanah J. Spurgin and Mary F. Spurgin, husband and wife, to The Prudential Insurance Company of America, secured by a mortgage upon real estate in Madison County, Iowa, dated March 1st, 1920, and recorded in said County on March 6th, 1920, in Volume 69 of mortgage records on Page 194, the sum of FIVE THOUSAND (\$5000). Dollars, with interest from March 1st, 1927, and,

WHEREAS, title to the mortgaged premises is now vested in Arthur D. Simmons subject to said note and mortgage, and,

WHEREAS, the said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW THEREFORE, the said Arthur D. Simmons and Mary M. Simmons, husband and wife, here by agree to pay the principal sum remaining due as aforesaid as follows:

FIVE THOUSAND (\$5000.) DOLLARS due March 1st, 1932.

with interest thereon from March 1st, 1927, to March 1st, 1932, at the rate of Five (5) per cent. per annum, payable annually; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:

Prepayment Privilege No. 1.
Privilege to pay \$100.00 or multiples thereof on account of principal on any interest payment day.

And the parties to this agreement hereby consent to said extension and agree that said note and mortgage shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force except as herein modified.

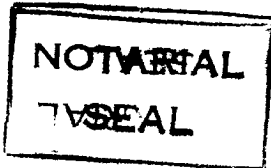
