SUPPLEMENTAL INDENTURE, dated March 25, 1927, between CENTRAL WEST PUBLIC SERVICE COMPANY, a corporation organized and existing under the laws of the State of Delaware (hereinafter called the Company) and FIRST TRUST AND SAVINGS BANK, a corporation organized and existing under the laws of the State of Illinois (hereinafter called the Trustee) and JOHN C. MECHAM, of the City of Chicago, Illinois, as Trustees under the Indenture hereinafter mentioned, (said First Trust and Savings Bank and John C. Mecham being hereinafter referred to as the Trustees).

Whereas, the Company has heretofore executed and delivered to the Trustees its First Lien Collateral Indenture dated November 1, 1926, (hereinafter called the Mortgage) to secure its bonds to be issued from time to time thereunder; and the Company under and pursuant to the Mortgage has executed \$4,000,000 principal amount of its First Lien Collateral 30-Year 5½% Gold Bonds of Series A and has delivered said bonds to the Trustee for authentication and delivery by the Trustee; and

Whereas, the bonds so executed by the Company and delivered to the Trustee are designated upon their face to be bonds of Series A and bear a form of trustee's certificate reading as follows:

"This bond is one of the bonds described in the within mentioned mortgage

Whereas, the Company desires the Trustee to authenticate the bonds so delivered to it by execution of the certificate thereon endorsed and to deliver the bonds so authenticated and

Whereas, the Trustee is willing so to authenticate and deliver said bonds in consideration of the execution of this agreement by the Company;

Now Therefore, this Indenture witnesseth:

That in consideration of the premises and authentication of said \$4,000,000 principal amount of Series A. bonds by the execution by the Trustee of the certificate thereon endorsed, and of the acceptance of said bonds so authenticated by the holders and owners thereof, and of other good and valuable considerations, the receipt whereof is hereby acknowledged, the Company hereby adopts, approves, ratifies and confirms the form of trustee's certificate endorsed on said \$4,000,000 principal amount of Series A bonds, for all purposes of the Mortgage, both with respect to said \$4,000,000 principal amount of Series A bonds and with respect to any and all other bonds that shall be issued under the Mortgage and authenticated by a similar certificate, and agrees that the execution of a certificate in such form by the Trustee shall be as effective for all purposes under the Mortgage as if said trustee's certificate endorsed upon said \$4,000,000 principal amount of Series A bonds were identical in wording with the form of certificate expressed in the Mortgage, and that such execution by the Trustee shall be deemed to be in substantial compliance with the Mortgage for all purposes thereof.

This Supplemental Indenture may be simultaneously executed in any number of counterparts and all said counterparts executed and delivered, each as an original, shall constitute but one and the same instrument.

IN WITNESS WHEREOF, said Central West Public Service Company has caused this instrument to be executed in its corporate name by its President or one of its Vice Presidents, and its corporate seal to be hereto affixed, attested by its Secretary or an Assistant Secretary and said First Trust and Savings Bank as Trustee as aforesaid has caused this instrument to be executed in its corporate name by its President or a Vice President, and its corporate seal to be hereto affixed, attested by its Secretary or an Assistant Secretary, and said John C. Mechem, as Trustee as aforesaid, has signed and sealed this instrument, in several counterparts, all as of the day and year first above written.
