Affidavit.

State of Iowa, Madison County, ss:

I, J. F. Handley of said County and State being first duly sworn upon oath depose and say that I am now and have been a resident of Madison County, Iowa, for more than 25 years last past.

I further state that I am well and personally acquainted with Homer Tilton named in the Order of Court entered Jan. 3, 1927, in the matter of the Estate of J. Clyde Lewis, deceased, which Estate is entered in Probate Docket "G", page 341 in the Office of the Clerk of the District Court of Madison County, Iowa, and in the Commission to Appraisers issued in said Estate of Jan. 3, 1927, and know of my own personal knowledge that said Homer Tilton is the same person as H. G. Tilton, who subscribed to the Oath as Appraiser under said Commission, and the same person as H. G. Tilton who joined in the Report of Appraisers filed in said Estate, - Homer G. Tilton being his full, true and correct name.

I further state that I was well and personally acquainted with J. C. Lewis, grantee in the Warranty Deed recorded in Deed Record 50, page 576 of the records in the Office of the Recorder of Madison County, Iowa, conveying an undivided 1/2 interest in the NW $\frac{1}{2}$ SW $\frac{1}{2}$ and the E $\frac{1}{2}$ SW $\frac{1}{2}$ of Section 29, in Township 74 North, of Range 28, West of the 5th P. M. Madison County, Iowa, and know of my own personal knowledge that said J. C. Lewis was the same and identical person as J. Clyde Lewis one of grantees in the Deed recorded in Deed Record 52, page 347 of said records, and the same and identical person as J. Clyde Lewis whose Estate was probated in the District Court of Madison County, Iowa, and entered in Probate Docket "G", page 341 of the records in the Office of the Clerk of said Court. In other words wherever the names J. C. Lewis and J. Clyde Lewis appear in connection with the title to said NW $\frac{1}{2}$ SW $\frac{1}{2}$ and E $\frac{1}{2}$ SW $\frac{1}{2}$ of Section 29, Township 74, Range 28 they in each and every instance refer to one, the same and identical person.

I further state that I am in no way interested in the title to the land above described, but make this affidavit at the request of the present owners thereof for the purpose of establishing of record the facts herein stated.
