EXTENSION OF MORTGAGE.

P.M. Iowa, And whwereas one E.K. Eberhart is now the owner of said Real estate, and as a part of the purchase price of said land assumed and agreed to pay the mortgage indebtedness above referred to and whereas the principal of said notes remains unpaid, and the installment of interest thereon which matured March 1st 1926 remains unpaid, and whereas the said A. Tusha is now dead and by his last will the said notes, became the property of R.E. Tusha and Estina Belle Allen, who are still the owners and holders of said Notes, and whereas the said E.K. Eberhart desires to procure an extension of the time of payment of said mortgages, which was duly filed for record in Madison County, Iowa, and is recored on Pages 328 & 329 of Land Mortgage record 65 of the records of Madison County, Iowa, for a further term of five years from March 1st 1929.

Eberhart, towit Maude K Eberhart, and his motherinlaw M.M Kingman, the time of payment of said Notes and each of them is hereby extended until March 1st 1934, with interest at five per cent as specified in the original notes, except the \$500.00 of the principal of each of of said notes, is to be paid March 1st 1930, \$500.00 March 1st, 1931, \$500.00 March 1st 1932, \$500.00 March 1st 1933, and the remainder of \$6500.00 on each note on March 1st 1934.
