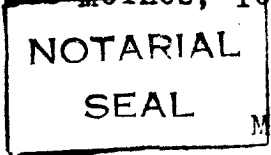

EXTENSION OF MORTGAGE

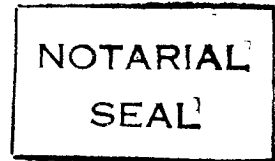
