whereas, on the 2nd day of June, 1924, Fred Eichner of Booneville, Iowa, executed and delivered to THE NORTHWESTERN MUTUAL LIFE INSURANCE COMPANY of Milwaukee, Wisconsin, a note in the sum of five thousand _______ secured by a mortgage of even date therewith upon certain real estate situated in Madison County, Iowa, filed for record in said County on August 14, 1924 and recorded in Volume 63 of Mortgages, on page 587 and there remains unpaid of the principal of said note the sum of five thousand dollars with interest from June 2, 1929;

And the parties hereto hereby agree that said note and mortgage shall continue a first lien upon said premises and shall remain in force, with all their covenants and conditions, except as herein modified.
