AGREEMENT
NOT TO CONVEY

THIS AGREEMENT made this 1st day of Sept. 1932, between Charles H. Busch and R. Myrtle Busch, husband and wife, as party of the first part, and THE FEDERAL LAND BANK OF OMAHA, of OMAHA, NEBRASKA, as party of the the second part, as follows:

1. In consideration of an extension, granted by the party of the second part, of the time for payment of certain instalments and/or other obligations upon a note in favor of the party of the second part, secured by a mortgage upon certain real estate of which the party of the first part is the fee owner, situated in Madison County, Iowa, described as,

N $\frac{1}{2}$ NE $\frac{1}{4}$ & NE $\frac{1}{4}$ NW $\frac{1}{4}$ Section 29 in Twp. 75 North Range 29 West) and The
W $\frac{1}{2}$ SE $\frac{1}{4}$ Section 4 in Twp. 75 N. Range 28 W.) (and 447 acres in Sec-
tions 17 and 20 Twp. 75 N. Range 28 as follows: as recorded in
book 78 page 187.)

(said mortgage being recorded in Book 78-80-80, at page 187-52-57, of the mortgage records of said county), the party of the first part hereby covenants, for a period of three years from the date of this agreement, not to sell or convey said real estate to any third party without the express consent of the party of the second part, nor to lease said property without such consent, nor to make an assignment of any lease, nor to do any other act that may impair the security of the mortgage of the party of the second part in any manner whatsoever. It being intended to describe all of the land under mortgage by the undersigned to the said Federal Land Bank of Omaha

2. It is further agreed that if the party of the (first) part shall attempt to make any conveyance of said real estate, lease, or assignment of lease, during such three year period, without the express consent of the party of the second part, such conveyance, lease or assignment shall be void.

3. The purpose of this agreement is to maintain the present status of the mortgage security of the party of the second part and to protect it against any possibility of waste,

impairment or damage which might result from a change in ownership or possession during such three year period. The right of the party of the second part to institute foreclosure under its note and mortgage at any time for any subsequent delinquency is in no manner limited or affected by the making of this agreement, but regardless of whether the loan is kept in good standing or becomes delinquent, any attempted conveyance, lease or assignment by the party of the first part shall be void.
