EXTEMSION OF MORTGAGE

THIS AGREEMENT made and entered into this 1st day of March A. D. 1932, by and between J. R. 1934, \$50 on September 1, 1934 and \$1050 on March 1st, 1935, at which time the said party of the first part hereby assumes and agrees to pay and discharge the same with all costs and expenses as well as interest approach or to accrue, at the Office of the SECURITY LOAN AND TITLE COMPANY, of Winterset, Iowa, and the said party of the second party does by these presents consent and agree to the extension of said mortgage indebtedness as above set forth.

It is further agreed that all the terms, conditions and stipulations contained in said note and mortgage shall continue in full force and effect excepting only as modified by this agreement.
