The said parties of the first part hereby covenanting that the above described premises are free from any incumbrance, and they will Warrant and Defend the Title unto the said party of the second part her heirs and assigns against all persons whomsoever lawfully claiming the same. Provided always, and these presents are upon this express condition, that if the said Daniel M. Hench and Ellen Hench, their heirs, executors, or administrators, shall pay or cause to be paid to the said Maria M. Boulware, her executors and administrators or assigns, the sum of Six Hundred Twenty-five (\$625.00) Dollars on the 28th day of November 1938 with interest thereon at seven per cent, according to the tenor and effect of the one promissory note of the said Daniel M. Hench and Ellen Hench payable to Maria M. Boulware bearing date November 28, 1933, then these presents to be void, otherwise to remain in full force.
