EXTENSION AGREEMENT

THIS AGREEMENT, Made and entered into this 27th day of December, 1932, by and between Jennie Archer Jesse and Joseph L. Jesse, wife and husband, the present owners of the mortgaged premises, party of the first part, and W. T. Guiher, the present owner of of said mortgage, party of the second part, WITNESSETH: That said parties aforesaid have agreed and do hereby agree concerning a certain mortgage made and executed by Eliza A. Archer to E. E. McCall upon the SE $\frac{1}{4}$ NE $\frac{1}{4}$ 8-75-26, except S 6 rods, said mortgage being recorded on page 121 of Book 65 of the records of Madison County, Iowa, as follows, to-wit:
