AGREEMENT FOR EXTENSION.

THIS AGREEMENT, Made and entered into this 15th day of February, A. D. 1933, by and between Vern Short and Susie Short, of the County of Madison and State of Iowa, present owners of the mortgaged premises, parties of the first part and Lewis Jacobs and Jessie Jacobs, of Madison County, Iowa, parties of the second part, WITNESSETH: That said parties aforesaid have agreed and do hereby agree concerning a certain mortgage, made and executed by first parties to W. F. Craig, Administrator and by him assigned to W. T. Guiher and by W. T. Guiher assigned to second parties, recorded on page 224 of Mortgage Record 71 of the records of the County Recorder of Madison County, Iowa, as follows, to-wit: That the note by said mortgage secured is still unpaid; That there is unpaid upon said note as principal the sum of Two Thousand Fifty (\$2050.00) Dollars, which sum said first parties hereby promise to pay and discharge when it shall become due as below stated with all costs and expenses as well as interest accrued or to accrue; That the time of payment of Two Thousand Fifty (\$2050.00) Dollars principal, due March 1st, 1933, is hereby extended for the term of five (5) years from March 1st, 1933 at five (5%) per cent per annum, and first parties have the option of paying One Hundred (\$100.00) Dollars or any multiple thereof at any time, by paying the interest on the sum paid from the last interest date to the date of payment. All payments hereafter made on said note are to be endorsed upon this Extension Agreement.

That all stipulations in said note and mortgage, not herein changed, are expressly kept in force.
