MORTGAGE

KNOW ALL MEN BY THESE PRESENTS:

That A. C. Jensen and Emma E. Jensen (Husband and wife) of Madison County, and State of Iowa in consideration of the sum of Nine Thousand# (\$9,000_00) DOLLARS, in hand paid by Ferdinand Jensen of Dallas County, and State of Iowa do hereby SELL AND CONVEY unto the said Ferdinand Jensen the following described premises situated in the County of Madison and State of Iowa to-wit:

The East One-half of the South-west Quarter, and Twenty-five Acres off the West Side of the South-east Quarter of Section Four (4), in Township Seventy-seven (77) North, Range Twenty-seven (27), West of the Fifth Principal Meridian, Madison County, Iowa,

And we hereby covenant with the said Ferdinand Jensen that we hold said premises by title in fee simple; that we have good right and lawful authority to sell and convey the same; that they are free and clear of all liens and encumbrances whatsoever; and we covenant to warrant and defend the said premises against the lawful claims of all persons whom soever; and the said A. C. Jensen and Emma E. Jensen hereby relinquish their right of dower in and to the above described premises.

PROVIDED, always and these presents are upon this express condition, that if the said A. C. Jensen and Emma E. Jensen heirs, executors or administrators shall pay or cause to be paid to the said Ferdinand Jensen executors and administrators or assigns, the sum of Nine Thousand# Dollars, on the First day of March, 1938. with interest thereon at 4% from March 1, 1933 according to the tenor and effect of the One promissory note of the said A. C. Jensen and Emma E. Jensen payable to Ferdinand Jensen bearing even date herewith then these presents to be void, otherwise to remain in full force.

It is hereby agreed that said A. C. Jensen and Emma E. Jensen shall pay all taxes and assessments levied upon said real estate before the same shall become delinquent, and in case not so paid, the holder of this mortgage may pay such taxes or assessments and be entitled to interest on the same at the rate of eight per cent per annum, and this mortgage shall stand as security for such taxes, assessments and interest so paid.

That so long as this mortgage shall remain unpaid the said A. C. Jensen and Emma E. Jensen shall keep the buildings thereon insured in some responsible company or companies which shall be satisfactory to the holder of this mortgage for the use and security of said mortgagee in the sum of not less than \$3,000_00, and shall deliver the policies and renewal receipts therefor to said mortgagee, and if the said A. Jensen fails to effect such insurance in manner as agreed, then said mortgagee may effect such insurance, and the amount paid for such purposes by the mortgagee shall be recovered from A. C. It is also agreed that the taking possession thereof as above provided shall in no manner prevent or retard the collection of said sums by foreclosure or otherwise.

It is further agreed that in the event action is brought to foreclose this mortgage, the court shall have the right and power to appoint a receiver to take possession of said premises and apply the rents and profits therefrom upon said indebtedness.
