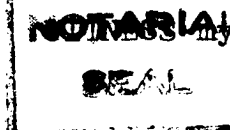

KNOW ALL MEN BY THESE PRESENTS: That the undersigned Reconstruction Finance Corporation a corporation organized and existing under and by virtue of an Act of Congress, entitled, "Reconstruction Finance Corporation Act", approved January 22, 1932, as amended, does hereby certify and declare that that certain real estate mortgage, in the original principal sum of \$20,693.00, made, executed and delivered under date of August 1, 1933, to it, as second party by Iowa National Fire Insurance Company, a corporation of Des Moines, Iowa, as first party, and recorded in Book 85, on page 44, of Recorder of County of Madison, and State of Iowa, which said mortgage covers real estate situate in said Madison County, more particularly described therein, is, together with the debt secured thereby, fully paid, satisfied and discharged, and said mortgage is hereby released, and said Recorder is hereby authorized and directed to enter of record the payment and satisfaction of said mortgage, and of the note evidencing said debt, and the said release.

Provided, always, ^{less} ~~nevertheless~~ that nothing herein contained shall in any wise now or hereafter (a) effect, alter or diminish the remaining balance or balances of any sum or sums, now due or to become due the undersigned from said Iowa National Fire Insurance Company together with interest thereon, to secure the repayment of which said note and mortgage were executed, delivered and pledged to the undersigned, or (b) affect or alter any note or notes, or other evidence of debt, evidencing said sum or sums, or the balance or balances of said sum or sums and interest thereon, or (c) affect, alter or diminish all and singular the security for said note or notes, or other evidence of debt, not heretofore or hereby duly released, surrendered, or discharged, or (d) affect, alter or diminish the remedies at law for recovering on said security, whether collateral or otherwise, and/or against said Insurance Company, and/or the assets of said Insurance Company, and/or the successors and assigns of said Insurance Company, the balance or balances of said sum or sums, whether as principal, interest or otherwise, according to the tenor and effect of said note or notes, or other evidences of debt.

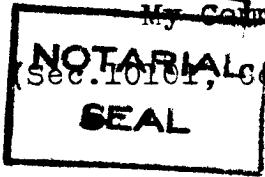
