MORTGAGE

THIS MORTGAGE, Made the I4 day of May 1935, by and between J.F.Roby, Ella Roby, W.D.Roby, and Wilma L. Roby of Madison County, and State of Iowa, hereinafter called the mortgagors and Mildred G. Hurst hereinafter called mortgagee.

WITNESSETH: That the mortgagor, in consideration of the sum of Eight Hundred Dollars (\$800.00) Dollars, paid by the mortgagee, do hereby convey to the mortgagee, her heirs and assigns forever, the following tracts of land in the county of Madison State of Iowa, to-wit:

All rights of homestead and contingent interest known as Dower, or however else, are hereby conveyed. To be void upon the following conditions:

First. That the mortgagors shall pay to the mortgagee or her heirs, executors or assigns, the sum of Eight Hundred Dollars (\$800.00) Bollars, on the 14 day of May A.D.1936, with interest according to the tenor and effect of the one certain promissory note with coupons attached of the said ----- bearing even dates with these presents; principal and interest payable at the office of Union State Bank at Truro Iowa.

Second. That the mortgagors shall keep the buildings on said real estate insured in some responsible company or companies, satisfactory to mortgagee, for the use and security of the mortgagee, in a sum not less than their insurable value, and deliver to the mortgagee the policies and renewal receipts.

Third. The mortgagors shall pay when due, and before delinquent, all taxes which are, or become a lien on said premises; of mortgagors fail either to pay such taxes or promptly to effect such insurance, then the mortgagee may do so; and should the mortgagee become involved in litigation, either in maintaining the security created by this mortgage, or its priority, then this mortgage shall secure to the mortgagee the payment and recovery of all money, costs, expenses or advancements incurred or made necessary thereby, as also for taxes and insurance paid hereunder; and all such amounts shall constitute a part of the hereby debt/secured, to the same extent, as if such amounts were a part of the original debt secured hereby, and with eight per cent per annum interest thereon, from the date of such payments.

And the mortgagors hereby pledge the rents, issues and profits of said

real property for the payment of said principal sum, interest, attorney's fees and costs, and authorize, agree and consent that in case of any default as above mentioned, and the filing of a bill or petition for the foreclosure of this mortgage, the court in which said suit shall be instituted, or any judge thereof, shall, at the commencement of said action or at any stage during the pendency or progress of said cause, on application of the plantiff without any notice whatever, appoint a receiver to take possession of said property, and collect and receive said rents and profits and apply the same to the payment of said debt under the order of the court; and this stipulation for the appointment of a receiver shall apply and be in force whether or not said property or any part thereof is used as a homeatead, and without proof of any other grounds for the appointment of a receiver than the default aforesaid.

And in the event a suit is lawfully commenced to foreclose this mortgage, mortgagee's reasonable attorney fees are to be considered as a part of the costs of the suit and collected in the same manner.
