Speer and Lloyd Speer of the County of Madison and State of Iowa, all the right, title, interest, claim or demand, whatsoever it may have asquired in, through or by a certain mortgage deed, bearing date the 16th day of September A.D.1929, and recorded in the Recorder's Office of Madison County, in the State of Iowa, in Book No. 82 of R.E.Mtgs, on page 298, to the premises therein described, situated in the County of Madison and State of Iowa as follows, to-wit:

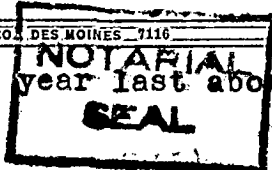
