EXTENSION AGREEMENT

That there is now due on said note the sum of Eight Hundred Fifty & 00/100 (\$850.00) Dollars, principal, on October 6th, 1934, which said sum the parties of the first part hereby assume and agree to pay, as though they had executed the note secured by said mortgage and to comply with the terms of said mortgage.

The parties of the first part have the option to pay any additional sum on the principal at any time by paying the interest on the sum paid from the time of the last payment of interest to the time the sum is paid on the principal.

It is expressly understood that the provisions of said note and mortgage not here-inbefore changed shall remain in full force.
