AGREEMENT FOR EXTENSION OF MORTGAGE

WHEREAS, on the First day of May 1929, Matilda H. WHEREAS, Matilda H. Bunnell is now the owner of the said real estate described in said mortgage (and has assumed and agreed to pay said note of FoureHundredeFifty Doklars), tand whereas, there remains unpaid on the principal of said Note the sum of Four Hundred Fifty Dollars, and

WHEREAS, the said Matilda H. Bunnell has agreed with the holder of said Note to extend the time of payment thereon,

NOW, THEREFORE, the said Matilda H. Bunnell hereby agrees to pay on the First day of May A.D.1941, the said principal sum of Four Hundred Fifty Pollars remaining unpaid on the said note and mortgage, with interest from none at the rate of none per cant per annum payable none on the first day of and in each year principal payable at Earlham Savings Bank, Earlham, Iowa; and the said Matilda H. Bunnell hereby covenants and warrant that said mortgage is a first lien on the land therein described and that it shall continue and remain as security for the payment of said principal remaining unpaid on said mortgage, and the interest, as herein before stated from none until paid; and in case of failure to comply with any one of the conditions hereof, or any of the conditions of the said mortgage, all the provisions of said nortgage becoming a part of this instrument, then the whole debt shall at once become due and collectible at the option of the owner of said mortgage; and all the covenants and conditions of said mortgage shall remain in force except as modified by this instrument; and all sums of money not paid when due as provided in this contract shall bear interest at the rate of 8 per cent per annum, payable semi-annually.
