WAIVER OF PRIORITY OF MORTGAGE

KNOW ALL MEN BY THESE PRESENTS, That the undersigned, the owner and holder of a certain mortgage, or mortgages, now of record covering the land described as:

The North Half(N/2)of the Southeast Quarter (SE/4) of
Section 13, Township 74 North, Range 24 West,
