AGREMMENT OF CANCELATION

THIS AGREEMENT, made this 8th day of July, 1937 by and between James J. Mulvihill, of the County of Madison and State of Iowa, hereinafter designated as the owner, and THE MUTUAL BENEFIT LIFE INSURANCE COMPANY, of the City of Newark, County of Essex and State of New Jersey, hereinafter designated as the Company, Witnesseth That

WHEREAS, under date of August 22, 1932, the said Company entered into an agreement in the nature of a grant of possession with Julia Mulvihill, James J. Mulvihill and Katherine Mulvihill, his wife, affecting certain real estate located in the County of Madison, State of Iowa, described as:
