EXTENSION AGREEMENT

THIS AGREEMENT made and entered into this 6th day of May, A.D.1938, by and between  
W.T.GUIHER, of Winterset,Iowa, the holder of a note executed by Helen McCall Huntoon,of  
date June 1st, 1926, for the principal sum of \$821.25, and secured by a mortgage dated  
May 25th,1933, and recorded on Page 29 of Mortgage Record 84 of the Records of the County  
Recorder of Madison County,Iowa, PARTY OF THE FIRST PART: and HELEN MCCALL HUNTOON and  
husband, H.V.Huntoon, the Mortgagors in said mortgage, PARTIES OF THE SECOND PART;WITNES-  
SETH that the Parties aforesaid have agreed and do hereby agree as follows:-

That on May 25th,1938 there will be the principal sum of EIGHT HUNDRED FIFTY & 00/100  
(\$850.00) DOLLARS due on said note;

That the time of payment of said note is hereby extended for the period of FIVE (5)  
YEARS from May 25th,1938, at the rate of FIVE ( 5%) PER CENT PER ANNUM, payable semi-  
annually, on May 25th, and November 25th of each year;

That Parties of the Second Part have the option to pay any amount at any time on  
said indebtedness ;


That all other provisions of said note and mortgage not herein changed shall remain  
in full force.
