Virvin and Elizabeth Kirvin to the said J.E.Long in the sum of One Thousand & no/100 (\$1,000.00) Dollars, said mortgage of the said Nora Allgeyer shall become junior and inferior and subordinate to the said mortgage of the said J.Y.Long, when the same is filed for record.

And the said Nora Allgeyer does hereby subordinate her said mortgage to the mortgage in favor of the said J.E.Long, made and executed by the said Patrick J. Kirvin, Anna A.Kirvin and Elizabeth Kirvin.
