ASSIGNMENT OF LAND CONTRACT

KNOW ALL MEN BY THESE PRESENTS:

That I, Clark W. Griffin, a widower, of Bayard, Iowa, for and in consideration of the sum of Six Hundred Seventy-five and no/100 Dollars (\$675.00) in hand paid by M. May Salzman, of Charles City, Iowa, the receipt of which is hereby acknowledged, do hereby, sell, transfer, quit claim, convey and assign, all right, title and interest in and to a certain land contract unto the said M. May Salzman, which said land contract is described as follows, to-wit:

A land contract dated December 11, 1937, by and between The Travelers Insurance Company, a Connecticut Corporation, as seller, and Clark W. Griffin, widower, as purchaser, said land contract being recorded in the Office of the Recorder of Madison County, Iowa, in Book 88 on Page 506, by the terms of which said land contract The Travelers Insurance Company agrees to sell and the said Clark W. Griffin, a widower, agrees to buy the following described real estate, to-wit:

The East Forty-six and one-half (E46 $\frac{1}{2}$) acres of the North Half of the Northeast Quarter (N $\frac{1}{2}$ NE $\frac{1}{2}$), except one-half ($\frac{1}{3}$) acre described as follows; Commencing at Southeast corner of the North Half of the Northeast Quarter (N $\frac{1}{2}$ NE $\frac{1}{2}$), running thence West Fifteen (15) rods, thence North five and one-third (N51/3) rods, thence East Fifteen (15) rods, thence South five and one-third (S5 1/3) rods, to place of beginning; also the West Half (W $\frac{1}{2}$) of the South Forty-six and one-half (46 $\frac{1}{2}$) acres of the East Ninety-three (93) acres of the Northeast Cuarter (NE $\frac{1}{4}$) of Section Twenty-one (21), Township Seventy-five (75) North, Range Twenty-nine (29), West of the 5th P.M., in Madison County, Iowa

for the agreed purchase price of Twenty-six Hundred and no/100 Dollars (\$2600.00) on which there has been paid the sum of Five Hundred Seventy-five and no/100 Dollars (\$575.00) in principal with interest to March 1, 1939, and the balance of said principal being payable at the rate of Seventy-five and no/100 Dollars (\$75.00) per year, beginning March 1, 1940, and continually thereafter until the principal sum has been reduced to Nineteen Hundred Fifty and no/100 Dollars (\$1950.00).
