MORTGAGE EXTENSION AGREEMENT

WHEREAS, Walter Benz holds a certain promissory note made by Lucy Clausen, Anna Clausen, Margaret Clausen, F.N. Clausen, Minnie Clausen, Christine Struck, George Struck, Ella Stearns, Earl Stearns, Clara C. Happel, Theo. Happel, Ida C. Jobst and Bert Jobst, for the sum of Five Thousand and no/100 (\$5000.00) DOLLARS, dated February 28th, A.D., 1934, payable to the order of Walter Benz and due March 1st, A.D., 1939, which note is secured by a mortgage of even date, upon Real Estate situated in the County of Madison and State of Iowa, and more particularly described in said mortgage deed, recorded in the Recorder's Office of said Madison County in Book 85, Page 386 of Mortgages; and whereas Lucy Clausen, Anna Clausen, Margaret Clausen, F.N.
