unto the Union State Bank of Winterset, Iowa, a certain mortgage and note therein set forth, said mortgage bearing date the 24th day of July A.D. 1937, which mortgage was recorded in Mortgage Record 87 at page 570 of the records of the County Recorder of Madison County, Iowa, to secure the payment of said note of the full amount of Three Hundred Fifty (\$350.00) Dollars and interest; and

Whereas, Mimi VanHook is the present owner of the property described in said mortgage, and the Union State Bank, Winterset, Iowa, the present owner of said note and mortgage, have this day agreed to extend the time of payment of the balance due of the principal sum of said note secured by said mortgage;

It is also mutually agreed that all the terms, conditions and stipulations in said note and mortgage contained and set forth are and shall continue in full force and effect, excepting only as modified by the foregoing agreement;
