STATEMENT OF RELEASE FROM LIABILITY

KNOW ALL MEN BY THESE PRESENTS: That The Federal Land Bank of Omaha, a corporation, of Omaha, Nebraska, and the Federal Farm Mortgage Corporation, of Washington, D.C., a corporation, existing under the provisions of the Federal Farm Mortgage Act of January 31, 1934, in consideration of the payment of \$1,000, and for other good and valuable consideration, do now hereby release Harry T. McKee and Sarah B. McKee, his wife; and Frank R. McKee and Cora A. McKee, his wife, from all personal liability that may exist on account of those certain promissory notes in the respective original principal amounts of \$6,000 and \$4,000, bearing dates of December 27, 1934, said notes being taken in connection with loans No. 37842 I 170 and 41392 IC 170 (J.W. McKee, et al), and both of said notes being secured by real estate mortgages covering the Northwest Quarter; and North 50 feet of the Southwest Quarter, of Section 35, in Township 76 North, of Range 28, West of the 5th Principal Meridian, in Madison County, Iowa; and these presents shall witness said release from personal liability on said promissory notes. No other parties are released by this instrument other than those stated, and all other rights under said promissory notes and the mortgages securing same are hereby preserved.

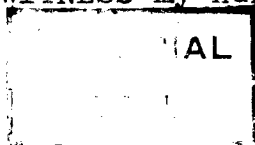
