Ink are the present owners of the property described in said mortgage, and the Union State Bank, Winterset, Iowa, the present owner of said note and mortgage, have this day agreed to extend the time of payment of the principal sum of said

Now Therefore, For Value Received, it is hereby agreed that the principal sum now fully and justly unpaid on the note secured by said mortgage is One Thousand Dollars (\$1,000.00) and that the same draws and is to draw interest at the rate of Five per cent per annum, payable semi-annually, to be computed from the 25th day of June, 1941, and the said principal sum shall become due and payable as follows, to-wit: One Hundred Dollars (\$100.00) on June 25th, 1942; One Hundred Dollars on June 25th, 1943; One Hundred Dollars on June 25th, 1944; (\$100.00) One Hundred Dollars on June 25th, 1945; and Six Hundred Dollars (\$600.00) on June 25th, 1946, at which times herein set out, the parties of the first part hereby assume and agree to pay and discharge same with all costs and expenses as well as interest accrued or to accrue at the Union State Bank, at Winterset, Iowa, and the party of the second part does by these presents consent and agree to the extension of said mortgage indebtedness as above set-forth;

It is also mutually agreed that all the terms, conditions and stipulations in said note and mortgage contained and set forth are and shall continue in full force and effect, excepting only as modified by the foregoing agreement.
